Section 1 - Who We Are

Chair's Report

The past year marks an important shift in national awareness and discussion, participation and leadership for economic transition. The need for a climate-safe, socially just and regenerate economy has been starkly highlighted by the challenges our local and global community is experiencing as a result of the COVID19 pandemic. It is inspiring to see new ideas, collaboration and action emerge in response, with momentum building around just transition opportunities.

The Next Economy has played an important part in catalysing and supporting this shift in thinking and action - with regional communities, industry and government. The value of this enabling work is increasingly recognised and in demand. Consequently, The Next Economy's team has been leading and contributing to a rapidly growing portfolio of work, ranging from direct support for regional communities seeking to accelerate transition, through to work with senior decision makers on strategy and policy, and capacity building with organisations similarly focused on social, economic and environmental justice.

Key achievements in the past year have included the development and delivery of energy transition forums, development and launch of the *What Queensland Wants* report and the provision of strategic advice and support to just transition alliances across Australia including the Hunter Renewal project, the recently formed Climate Justice Union in Western Australia and the Northern Territory Climate Justice Alliance.

It has been particularly rewarding to see a significant shift in support for The Next Economy's work, including an increase in annual revenue to just under \$500,000 in FY2020. This has enabled growth in our staff team and consequently expanded The Next Economy's depth of impact. Internally, our operations are maturing, and externally the organisation's profile has increased and includes regular national media coverage.

The Next Economy has a highly capable and passionate team of staff and volunteers, who bring empathy, creativity and boldness to their work. I would like to specifically acknowledge the strength of leadership provided by Dr Amanda Cahill over the past twelve months – rapidly growing The Next Economy's role and impact in what has often been a challenging and dynamic political and economic environment.

I would like to recognise the efforts of our directors to effectively fulfill their governance responsibilities then go beyond to support The Next Economy to excel.



We are delighted by the range of experience, networks and commitment they bring to the work we undertake.

I would also like to thank the many individuals and organisations who support The Next Economy. We are most grateful for the resources, encouragement and energy that this growing community contributes.

And so, our work continues. It feels like we are making important steps forward, yet there remains so much to be done. We look forward to working with you all in the coming year to accelerate the transition to an economy that protects and regenerates both people and the planet.

CEO's Report

It's with great pleasure that we present our inaugural annual report for The Next Economy Ltd. Over the last 18 months we've seen significant growth.

Highlights for the organisation have been numerous, however those worth particular attention include the development and delivery of energy transition forums to over 450 people across Queensland, including 8 forums on behalf of the Queensland Government in Cairns, Townsville, Gladstone and Rockhampton in 2020.

This led to us launching the What Queensland Wants report that generated intense and positive media attention across both the ABC and News Corp press during August and September 2020, and led to opportunities to work directly with the Queensland Government and a range of energy companies to support the development of transition strategies.

Our work in supporting and building capacity for organisations and alliances working towards a just transition across Australia also led to us working with groups in New South Wales, Western Australia and the Northern Territory, including the Hunter Renewal project, the Gloucester Sustainable Futures group, the Climate Justice Union and the Northern Territory Climate Justice Alliance.

We also expanded our work beyond energy to support a range of food justice and regenerative agriculture programs, including the Mackay-Isaac-Whitsundays Reef Resilience project and the Transforming Australia's Food Systems project.

We delivered a number of national addresses, including the Big Ideas event hosted by Latrobe University in September 2019, the Hobart Lecture in November 2020 and the ABC Facebook Live Event: Generation 2020. I was humbled to receive a 2020 Churchill Fellowship to travel to Europe to study how other countries are building long-term resilience by embracing the energy transition, which I hope to complete once the borders open globally.

None of these achievements would have been possible without the ongoing support of many passionate, capable and dedicated people, to whom I am deeply grateful, including: the best team anyone could wish for in Emma-Kate Rose, Debbie Gibson, Emma Whittlesea, Sharon France and Maddie Eyres. Lizzie Webb, who has not only chaired the board for the last two and a half years, but has offered hands-on, practical support in developing a whole range of systems and policies, as well as provided unwavering moral support.

I'd like to thank all of our board members, particularly the original 'girl power' team of Jarra Hicks, Sandi Middleton, Lisa Hyden, Lauren Haas and Lizzie Webb who supported TNE through the first two years of operation.



The dedicated Transitioning Australia Group (TAG) team members who have accompanied us across Australia, particularly Wendy Farmer, Jarra Hicks, Kristy Walters, Ron Ipsen, Verity Morgan-Schmidt, Dan Musil and Julie Lyford.

Thanks also to Kate Davies and the team at the Climate Media Centre who have provided timely support to launch us into local, state and national media at pivotal moments, as well as our key partner organisations, including the Australian Conservation Foundation, Beyond Zero Emissions, Farmers for Climate Action, IEEFA and the Community Power Agency.

Last but not least, our generous donors, particularly The Morris Family Foundation who have backed The Next Economy from day one and continue to be our greatest champions.

All of this support has meant that The Next Economy was able to move quickly when the results of the 2019 election led to the widespread realisation that Australia would never see meaningful action on climate change unless we were able to bring everyone along with us. It also meant that we were able to share practical support and insights into how we could navigate the challenges of the COVID pandemic in ways that would strengthen social, economic and environmental wellbeing with leaders across government, industry, civil society and regional Australia.

As the climate crisis intensifies and global economic outlooks remain uncertain, there will only be increasing demand for what The Next Economy can offer in terms of advice, support and action. I look forward to continuing to work with you all to keep building a world in which everyone can reach their potential in ways that strengthen and nurture the planet on which we all depend.

About Us

Communities and organisations all over the country are feeling the burden of economic change, often bearing the brunt of policies that don't appreciate the true value of regional economies. Change is inevitable, and with that comes great anxiety. But it also comes with great opportunities. We work alongside communities, industries and governments to harness those opportunities that will work for people and the planet on which we all depend.

We provide a safe and supported structure for communities to move towards a more prosperous, fair and sustainable system. In an atmosphere that is often politically and emotionally charged, we endeavour to create spaces for people to come together, reflect, and develop practical and positive economic solutions that fit with the particular circumstances of each community.

Our Theory of Change (and reason for being)

It is no secret that our economic systems are not serving the vast majority of people on the planet. Even the wellbeing of people with access to immense wealth is being undermined by the ongoing degradation of the environment, climate change and growing social divisions.

The good news is that all around the world, people are experimenting with ways to meet the needs of people more equitably and justly, while also regenerating natural ecosystems and addressing climate change.

The solutions to transform the status quo are already here, along with the technology, resources and expertise to implement them.

And yet at this crucial time, we are not on track.

Our political leaders remain paralysed by perceived opposition to change, unwilling to set meaningful targets and provide support to address the causes of climate change, inequality and environmental degradation. And while a growing number of people understand that the economy needs to change, very few have access to the knowledge, skills, resources and support they need to move from awareness to action.

The Next Economy has the tools to guide government, business, investors, workers and communities to manage economic change, while at the same time achieving meaningful climate action AND positive social and environmental outcomes. By working with people to develop strategies and access the knowledge, resources and expertise needed to implement them, we empower and connect key decision makers as they navigate economic change in an increasingly uncertain world.









Our History

The Next Economy was established in 2018 to support communities struggling with economic change to stimulate their economy in ways that protect and regenerate both people and the planet.

The idea for The Next Economy grew out of the work of the Founder at her previous organisation, The Centre for Social Change. After being asked to speak alongside financial analyst Tim Buckley in Mackay in 2014 about what communities could do to diversify their economy to protect themselves against changes in the international demand for coal, Dr Cahill became inundated with requests from coal mining areas in Queensland, New South Wales and Victoria to help them explore how they could manage the economic transition away from fossil fuels and towards renewable energy. What was most surprising about these requests was that the majority were coming from unlikely suspects: elected local government officials, heads of economic agencies and chambers of commerce, union representatives, state and federal government departments and industry peak bodies.

Amanda quickly realised that there was a huge gap in the current climate movement, in that most organisations were focussed on national campaigning and activism, or on developing and promoting technical solutions. Very few were talking about climate change as an economic opportunity that could create new jobs and industries, while also addressing a number of other challenges that regional Australia was facing, including ongoing droughts, population decline, workforce shortages and reduced services. Furthermore, in her visits to regional areas, Amanda started to see how climate change was increasingly being used to drive a wedge between rural and urban communities.

Concern about this growing division, along with ongoing political opposition to climate action and a growing demand for support to manage the already changing economies in coal regions led to Amanda establishing The Next Economy in 2018.

Section 2 - Pathway to Impact

Our Activities

It has been just over 18 months since our last AGM, with the COVID pandemic postponing our planned 2020 AGM. Much has changed in this time, particularly for The Next Economy that has seen significant growth including:

- The establishment of the Transitioning Australia Group to assist in the delivery of services across Australia.
- A quadrupling of our income from \$137,896 in FY2019 to \$445,192 in FY2020.
- An expansion of TNE's profile nationally, with project activities extending across four states and two territories; extensive media coverage of our activities by the national press; and presentations delivered to around 20,000 people since June 2019.
- The establishment of more formalised systems in the areas of finance, risk management, HR, document control, CRM and project management to support the smooth function of the organisation.

Over this time, the TNE team worked across all economic sectors to accelerate the transition to a climate-safe, socially just and regenerative economy by:

Queensland Energy Transition Roadshow


We worked with the Queensland government's Just Transitions Group to develop transition related policies and programs, including the Energy Transition Roadshow (in Rockhampton, Gladstone, Townsville and Cairns) funded by the Oueensland Government in 2019/20. We also delivered additional forums in Townsville, Toowoomba and Kingaroy with the support of philanthropic donations. Overall we talked transition with over 450 Queenslanders and gathered their ideas on how to accelerate change in a sustainable and just way.

Through this work, we brought together all levels of government, industry, unions, universities, environment and community groups together to explore how the energy transition was impacting on regions and how it could generate new economic opportunities. The recommendations of these workshops were fed into government policy and generated significant local and state media interest.

What Queensland Wants Report

As the COVID pandemic hit, The Next Economy compile the many economic stimulus ideas we'd collected from across Oueensland into a report called "What Queensland Wants". The report was well received by the State government, with a number of the recommendations being adopted as election promises.

The report also generated extensive media and public interest when it was released, garnering more than 62 media mentions, articles syndicated across 19 regional News Limited publications, 5 radio interviews and a regional television interview. The media attention in turn generated further interest from state and federal MPs.



The Next Economy also worked with a number of groups across the Hunter Region during 2019-2020, including Hunter Renewal, the Gloucester Sustainable Futures **Group** and the **Hunter Jobs Alliance**.



Influence

We've provided **expert testimonies** to four government inquiries on matters related to the energy transition and regional economic opportunities, in addition to holding meetings with ministers and key stakeholders in state and local governments, as well as industry bodies, unions and energy corporations.

Stanwell Energy Corporation strategic advice

We have been advising Stanwell in the development of their corporate strategy, which has led to the company not only integrating transition planning into their 5 year strategy but has also led to the development of a workforce and community engagement plan to enable the company to start talking about the inevitability of transition out of coal.



Qld Energy Policy







In the wake of the 2019 Federal Election, TNE was able to share the findings of previous transition strategy workshops undertaken in the Hunter Valley and Queensland to challenge the divisive rhetoric that all of regional Australia (especially Queensland) was actively opposed to and in denial of the energy transition. The results from the workshops were used in a widely-shared Guardian article written by CEO Amanda Cahill, that showed that many people were starting to accept that the transition is inevitable, and that there were a number of economic challenges across regional Australia that was exacerbating fear, uncertainty and division.

This article caught the attention of the Deputy Premier of Queensland, who was concerned about the growing division across the State. At the invitation of the Deputy Premier, Amanda participated in a community forum, where she challenged the government's view that they should avoid talking about transition. Subsequent meetings led to Amanda convincing the State Government to fund the Energy Transitions Roadshow mentioned above.

Civil Society Organisations

The Next Economy has also worked with a number of social service organisations, who are grappling with the implications of the energy transition and climate change for the vulnerable and marginalised groups they work with. This has included facilitating a range of training workshops for staff of the Red Cross and Brotherhood of St Lawrence, as well as providing strategic advice and presentations to The Australian Council of Social Services and Queensland Council of Social Services.

Education, Outreach and Awareness

- Worked with 12 regional communities across Queensland, NSW, Victoria, and Western Australia to raise awareness and acceptance of the transition and to start to develop transition strategies, collaborations and initiatives. Most of this work has been in regions economically dependent on coal/gas mining and electricity generation, including the Hunter Valley in NSW; Central Queensland, Townsville and the Darling Downs in Queensland; and the Latrobe Valley in Victoria.
- Contributed to the development of and appeared in the film 2040 and consulted to Craig Reucassel on his influential documentaries Fight for Planet A and Big Weather. Also advised on a number of ABC initiatives covering climate change in 2019-2020, including the augmented reality app "Mt Resilience".
- Between July and December 2019, we presented live to at least 15,000 people, with recordings accessed by at least 50,000 people. Highlights included:
 - Talking with Damon Gameau at a range of community screening events of 2040
 - Presenting with Bob Brown on stage at the La Trobe University's Big Ideas event
 - A workshop at the Progress Conference in Melbourne
 - On a panel at the Impact Investing Summit
 - At the prestigious Australian Academy of Social Sciences
 - Hosting the webinar series: 2040 Conversations
- Generated significant and positive media coverage, including:



- Over **20 articles** written about the work of TNE and three opinion pieces that were shared across at least 30 news platforms (including more conservative news sites such as News Limited)
- Over **20 radio interviews**, both local, regional and national radio programs
- 3 television interviews, across both ABC and commercial channels

The company has a donations sub-account with the Foundation for Rural and Regional Renewal, which provides deductible gift registry (DGR) status to The Next Economy Ltd. A strong governance framework allows our lean organisation to maintain operating rigour.
